## PREFACE & INTRODUCTION OF PRAVARA INSTITUTE OF MEDICAL SCIENCES-DU

### The Beginning :

**Pravara Medical Trust** was established in 1972 by the rare visionary, most revered and respected, Padmashri Awardee, Dr. Vitthalrao Vikhe Patil, the founder of first co-operative sugar factory in Asia, in 1948, at Loni – a remote village of Maharashtra, a feat appreciated by **Pafidit Jawaharlal Nehru**, the Prime Minister of India. He also initiated and led Pravara cooperative movement for inclusive-holistic rural development, education and health care. The functional and realistic model of integrated, participative, sustainable rural development as well as comprehensive holistic health care and education, successfully launched by the rare visionary and ambassador of socioeconomic change, is popularly known as “**Pravara-Loni model of PURA**”, commended by **Dr. APJ Abdul Kalam**, the then President of India.

### The Background :

**Dr. Vitthalrao Vikhe Patil**, a farmer of Loni, a draught prone backward village of Maharashtra, realized the importance of integrated rural development to solve the problems of illiteracy, poverty, hunger, unemployment, social inequality, economic exploitation, poor public and personnel health, shelter, clothing and basic amenities in rural areas, which were the real challenges before a young independent India in 1947. The rare visionary was with full of ideas, courage and determination to address these issues head on directly. He initiated the revolutionary cooperative movement of farmers to achieve the impossible – “integrated holistic sustainable rural development”. He aimed at realizing “Gram Swaraj” in true letter and spirit. The cooperative movement of farmers led by him, aimed at the issues of agriculture, livestock development and agrobased industry (1948), primary, secondary and collegiate education (1964) and cooperative banking (1972). All these initiatives started transforming the draught prone backward village towards the path of integrated sustainable rural development–social, political, economical. This realistic cooperative model was appreciated by one and all, across the nation.



In order to address the issues of comprehensive rural health care, he established the **Pravara Medical Trust** in 1972, **Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital**, in 1976 at Loni and several rural health centres.

For this illustrious social work and sacrifice, Government of India honoured him with the award of **"Padmashri"** in 1962. Pune University conferred on him the honorary D.Lit in 1978 and established a Chair in his name to undertake Research in Rural Development (1981). Mahatma Phule Krishi Vidyapeeth conferred on him the honorary D.Sc. in 1979.

Film Division of India presented a documentary film on his achievements entitled **"Shoulder to Shoulder"** in 1953. Veteran Girish Karnad directed a documentary **"Sweet Revolution"** in 1986, based on his accomplishments. Shri Rajamangal Vedekar and Shri. Shivajirao Sawant have written biographic books (1977/ 1985) on the life and mission of this illustrious leader. We offer our tributes to this cellular visionary.

### **Development, Consolidation and Expansion of Co-operative Movement :**

The mission and ideas of this great visionary were further developed and nurtured by his son **Dr. Balasaheb Vikhe Patil, Padmabhushan Awardee**, Parliamentarian (8 times), Statesman, humble social worker and visionary leader of masses. He continued the cooperative movement for integrated rural development and further strengthened comprehensive rural health care & established Health Protection Colleges at Loni .

To meet the national requirement for qualified health professionals, PMT established the following colleges:

1. Dr. Balasaheb Vikhe Patil Rural Medical College (Formerly Called as a Rural Medical College) (1984)
2. Rural Dental College (1989)
3. Dr. APJ Abdul Kalam College of Physiotherapy (1997)
4. Smt. Sindhutai Eknathrao Vikhe Patil College of Nursing (Formerly Called as a College of Nursing) (1998)
5. School of Public Health and Social Medicine (Formerly Called as a Centre for Social Medicine) (2001)
6. College of Biosciences and Technology (Formerly Called as Centre for Biotechnology) (2001)
7. College of Pharmaceutical Sciences (2022)
8. Pravara Rural Ayurved College (2023)

These constituent colleges have the approval and recognition of respective statutory councils (MCI, DCI, INC, MSOTPT, UGC).

## Genesis of the University : PIMS-DU

In order to achieve the integrated holistic approach in health care, education and research, Pravara Medical Trust (PMT) took positive steps towards the establishment of a deemed university (with the approval of UGC, MHRD, GOI) by bringing all of its colleges and units of health education and tertiary medical hospital under one ambit/ umbrella, in 2003. Thus, the **Deemed to be University** was born at Loni-”**Pravara Institute of Medical Sciences (PIMS-DU)**”, a unique feature in Indian professional education system in a rural India. The governance, leadership and management of PIMS-DU are as per regulations governing deemed to be universities, notified by the UGC from time to time (UGC institution deemed to be universities regulations 2010/ 2016/ 2019).

Befitting to the vision and mission of the parent trust, PIMS-DU is imparting quality professional health education at global level and tertiary specialty health care at Loni as well as at doorsteps of 234+ villages spread over 13 talukas and 3 districts with a catchment area of lakhs of peoples of Maharashtra State. Our rural health care, extension and community health outreach activities have received international and national appreciation and recognition.

### Growth and Development of PIMS-DU :

PIMS-DU is raised up as on a spacious and green unitary campus on 120 acres at Loni, developed as per the master plan and land scaping, housing all the 8 constituent units and its rural hospital. It has state of the art building blocks for academic and co-academic programmes, multispecialty tertiary medical and dental hospitals as well as residential facility for students and staff on the campus, all within a walkable distance. It is a near cent percent residential campus provided with all the basic amenities and facilities round the clock, ensuring a home away from the home. It is providing a good multispecialty hospital for enriching clinical resource and care, central library, IT facilities, safety, security, discipline and basic amenities 24x7(water, electricity, maintenance) in a rural area, a real practice of “PURA”. It has recruited qualified and experienced staff as per norms of statutory bodies. We have encouraged research through funds, facilities, and incentives resulting in 2000+ publications and collaborative research projects and clinical trials. PIMS-DU publishes its own ISSN peer reviewed medical journal entitled “Pravara Medical Review” indexed in Scopus and UGC list of journals. We have collaboration with 35+ international institutions and industries as well as national institutions. Teachers and students have visited foreign universities on scholarship/ fellowship through Lineus Palme Exchange Accord and Erasmus+ scheme (only the private deemed university from India included in this scheme).







It has attracted 200+ students and 50+ faculty from foreign universities for research and training. Centre for Social Medicine acts as Mother NGO and a liaisoning body for government and semi government organizations and national health schemes. PIMS-DU has a sound financial management and governance system with accountability, transparency and integrity. Annual convocations are held regularly since 2007. So far 15th convocations have been organized. We are proud for having contributed qualified and competent, health professional, human resource to the national development (Medical doctors, Medical specialists, Dentists, Dental specialists, Nurses, Nursing specialists, Physiotherapists, Specialists in physiotherapy, Biotechnologists, Public health specialists, Ph.D. holders, a total of 5164 graduates and postgraduates). Our students are enriched with good clinical and community health knowledge, skills and competence. We are proud of our “pravarites” serving in India and abroad.

### **Road Ahead :**

Pravara Institute of Medical Sciences - Deemed to be University, aspires to be “The Centre of Excellence” in Medical, Dental and allied Health Science education and is committed to improve health standards of this rural region. PIMS University is making every possible effort to provide globally competent higher education and service to the rural society with a focus on empowerment of rural people for sustainable growth and development. These developments were mainly due to the visionary leader Padmabhushan Dr. Balasaheb Vikhe Patil, our mentor, guide and philosopher. We pay our heartfelt tributes to our beloved leader.

With the benign blessings of Padmashri Dr. Vitthalrao Vikhe Patil and Padmabhushan Dr. Balasaheb Vikhe Patil, Founder President & Managing Trustee, PMT and under the guidance and leadership of Hon’ble Dr. Rajendra Vikhe Patil, Chancellor PIMS-DU, we are marching towards our goal - to create “A Healthy Society”.

PIMS-DU has grown over the years since its establishment in 2003 and recorded developmental milestones. It strives for global excellence. We believe in expansion, consolidation as well to grow and develop ahead to achieve global excellence, as per global and national expectations, trends and challenges.

We believe in quality movement in all our endeavors. Hence we subject ourselves for continuous regulation and monitoring by statutory bodies – MCI, DCI, INC, PCI, NCISM, OTPT and UGC. We volunteered ourselves for assessment by NAAC in 2017 and got reaccredited with ‘A’ grade with CGPA score of 3.17 on a 4 point scale. We have initiated the processes towards NABL Accreditation.

We subjected ourselves for UGC's Review of Deemed to be University in 2008 with good recommendation for significant growth and development. We were also reviewed by MHRD's Task force for the Review of Deemed to be Universities (by Dr. Tandon Committee) and were graded at 'B' level for good performance. We have submitted compliance report to Dr. Tandon Committee. Once again we have submitted ourselves for a review by UGC Expert Committee in July 2017. The visit of UGC committee to review the function of Deemed University was very much successful for the orientation towards the growth of the DU.

PIMS-DU participated in NIRF ranking 2018 for the first time and again in 2021 and both the times was placed in the rank band of 101-150 among the universities and of 151-200 among the overall institutions. We believe in growth and development of PIMS-DU and of the nation.

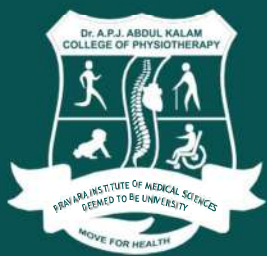

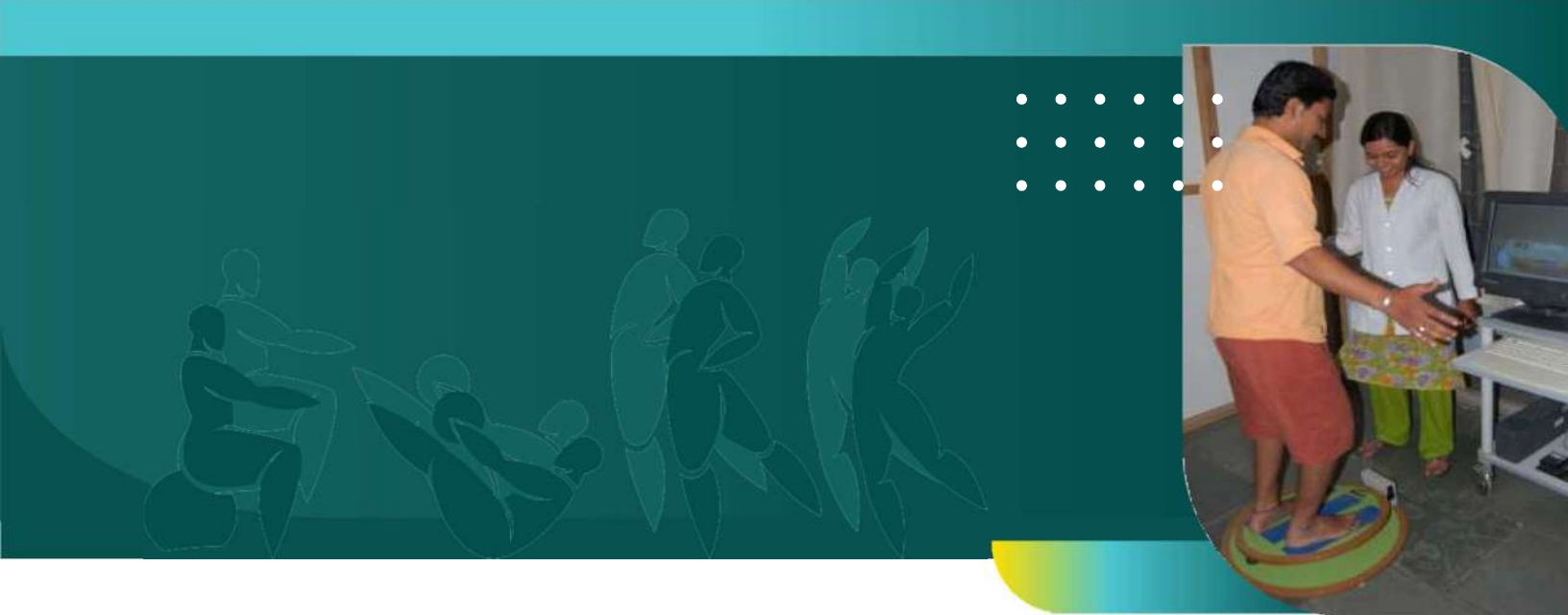
The College offers Undergraduate programme in Physiotherapy (B.P.T.) since its inception in 1997. Postgraduate program in Physiotherapy leading to Masters in Physiotherapy (M.P.T.) commenced from academic year 2005. Master’s programme is offered in the following six specialties:

1. Musculoskeletal Sciences
2. Neurosciences
3. Cardio Respiratory Physiotherapy
4. Community Based Rehabilitation
5. Paediatrics Physiotherapy
6. Sports Physiotherapy

Doctor of philosophy (Ph.D) programme in Physiotherapy commenced from Academic year 2010-11.

### Teaching Learning Program :

Practical training to students is imparted at state of the art Physiotherapy Departments in the college under the guidance of expert & experienced dedicated faculty. Participation of students is encouraged in various Physiotherapy camps, community activities and rehabilitation projects sponsored by Govt. of India and other International agencies to



enhance their knowledge & clinical skills. Observational and educational visits are organized to the Schools for Disabled, NGO Projects and Rehabilitation Homes all around the State for the students to gain exposure of different working environments and be aware about the latest advancements in the field of physiotherapy.

### **Curricular :**

The students are trained in basic as well as advanced Physiotherapy techniques used in various departments and Units of the **hospital which includes intensive and critical care units, Cardio-Respiratory & Cardio vascular department, Neurology Orthopaedic departments, Manual therapy Sports & Yoga, Paediatrics, Women's Health, Community Based Rehabilitation & Palliative Care.**

We believe more in Interactive learning rather than didactic lectures. Patient bed side teaching, Problem based learning, Peer Assisted Learning and Group discussions are essential components of learning in this institute.

### **Co-curricular activities :**

Integrated seminars, guest lectures and workshop are regularly organized and conducted for all the students on various occasions and students are motivated to participate actively in these activities

The School of Public Health and Social Medicine (SPHSM) (Formerly Centre for Social Medicine) was a culmination of efforts to address the multi-disciplinary & multi-dimensional needs of the under privileged and vulnerable sections of rural, tribal, and urban slum population, in a holistic way through education, research, vocational training in Public Health and Social Medicine and community health care and developmental services. The SPHSM was established as part of PMT & PIMS in 2001 to facilitate & enrich the faculty-student-community interactions and collaborates with all academic & research programs in the university campus which include Medicine, Dentistry, Nursing, Physiotherapy, Medical Biotechnology, and other Allied Health Sciences to implement its Unique Pedagogy of “Community Oriented Professional Medical and Health Sciences Education”.

The SPHSM (formerly CSM) was recognized by Ministry of HRD, UGC, Govt., of India as a Constituent Unit of PIMS-Deemed to be University for offering academic courses in Public Health & Social Medicine under “Faculty of Allied Health Sciences” since 2005.

### Academic Programs at SPHSM

The focus of education and training at the SPHSM is to promote the concept of “Health for All” through formal and informal socially meaningful, need based, community oriented, and problem-solving education.

The School offers unique need based formal University Degree & Diploma programs including Bachelor in Public Health (BPH) (Hons.), Master of Public Health (MPH), Master of Social Work in Health (MSW-Health), PG Diploma in Epidemiology and Biostatistics, PG Diploma in Hospital and Healthcare Management, Diploma in Optometry and Ophthalmic Assistant. Besides, the School offers short term Certificate Programs in (1) Social Health and Development (CSHD) for international students, (2) Arogya Mitra and (3) Health Promoting School for community members and Value Addition Certificate programs in (1) Global Health, (2) Tribal Health, (3) Project Planning & Management, (4) Basic and Advanced R-Programming (5) Community Oriented Primary Care (COPC), (6) Personality Development & Communication Skills, (7) Forensic Social Work for PIMS-DU students.

## DR.VITTHALRAO VIKHE PATIL PRAVARA RURAL HOSPITAL, LONI

Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital, & Medical Research Centre is 1275 bedded Multidisciplinary, Super specialty Hospital with the state-of-art gadgets, equipment's including 64 Rows 128 Slice CT Scan, 1.5 Tesla & 3 Tesla two dedicated MRI, 6MV Photon Linear Accelerator with IMRT & 3 DCRT well-equipped ICUs and ICCU. Besides Modern Hi-tech Central Clinical Laboratory (CCL), hospital houses Blood Bank with component separation facilities. Cancer Treatment & Research Centre is an important part of the hospital. A new Coronary Care unit has been functioning since past one year more than 600 angiography and 300 angioplasty operations have been performed successfully. Ancillary units such as Physiotherapy & Rehabilitation with Holistic Medicine departments for patient care are also available in the hospital.

The Hospital serves the rural and tribal population of Ahmednagar, Beed and Nashik Districts of rural Maharashtra. Free Pediatrics Heart Surgeries are performed, which is a unique facility, provided for the rural patients. Rural Cancer Treatment & Research Centre has established its own Rural Cancer Registry (Centre Code No. 513) and Day Care setup. Currently we have procured an advanced treatment facility of Linac with IMRT and high dose rate Brachytherapy system. The Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital, continues rendering quality services with visible accomplishments. The hospital assists State and Central Government to implement their National Public Health Programmes.





In view to cater to the Covid Pandemic, 100 bedded Covid Isolation Hospital with ICU facilities, has been established by Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital.



The hospital provides sophisticated diagnostic facilities like Ultra-sonography, Color Doppler, CT Scan, MRI, DSA, Mammography, Digital X-Ray with PACS, Congenital Anomaly Scan etc. at a reasonable rate to cater for poor patients.

Spacious specialty Out-patient departments and In-patient wards are available with residential expert medical and paramedical teams. Central Clinical Laboratory (CCL) consists of Pathology (Morbid Anatomy, Cytology, Haematology), Biochemistry and Microbiology, is well equipped and caters to the needs of patients. The hospital CCL also functions as a referral centre for nearby pathologists and laboratories. In view of the recent Covid Pandemic, NABL Accredited Molecular Biology lab has been established with RT PCR testing facilities.

The Blood Bank of the Hospital is equipped with state-of-art equipment's to perform routine and special investigations including HIV Test (Elisa reader) and separation of blood to prepare blood components. The blood component therapy has proved to be a boon for the needy patients. Dialysis Unit caters to the needs of high incidence of renal failure cases of CKD, insecticide poisoning and snake-bites etc., which is very common among agricultural workers.



Emergency and Trauma care is provided round the clock by experts. These services are augmented with the latest diagnostic facilities like invasive and non-invasive imaging techniques, on the spot transfusion and other resuscitative techniques.

Major as well as specialized surgeries including Pediatric, Cardiothoracic, Neurosurgical Oncology, Urology, Laparoscopic, Spinal, Micro Laryngeal, Oral & Maxillo Facial Surgery, Reconstructive and reconstruction surgeries are performed in a Centrally Air Conditioned Modular Operation Theatre Complex which are equipped with excellent operating and monitoring facilities.

Advanced Neonatal Unit, Neonatal Intensive Care Unit and Pediatric Intensive Care Unit takes care of preterm babies, critically ill neonates, infants and children ensuring an excellent salvage rate. Intensive Care Unit is well equipped with state-of-art monitoring and life support systems for the care of the critically ill.

CCU & ICCU is equipped with latest Ventilators, Multipara Monitors, External Cardiac Pace Maker and 24 hours continuous Holter ECG monitoring facilities, caters for the needs of critically ill cardiac patients.

A well-equipped Medical ICU's, Surgical ICU's and Respiratory ICU's caters for critically ill patients from these disciplines. Medical ICU also caters for facility of beside Hemodialysis.



Dr. Vitthalrao Vikhe Patil Pravara Rural Hospital, organizes regular Multi-diagnostic (multi-specialty) camps and Mini Medical camps including Dental camps to deliver health care at the “DOOR STEP” of the tribal and rural population. Patients requiring further specialized services were brought to main hospital for evaluation and treatment. Voluntary Blood Donation Camps are regularly conducted with the support from local NGO's.



### **Establishment of new Facility :**

Sai Abherna Cardiac Care Cath. Lab. Centre was established and inaugurated by Hon'ble Smt. Sindhutai Vikhe Patil in presence of Dr. Rajendra E. Vikhe Patil, CEO, PMT & Pro-Chancellor, PIMS-DU, Mrs. Monika Swapnil Sawant Inamdar, Trustee, PMT, Hon'ble Y.M. Jayaraj, Vice-Chancellor, PIMS-DU & Dr. Sunil Agrawal, Director, Sai Abherna Cardiac Cath. Lab Centre.

- Laundry facility.



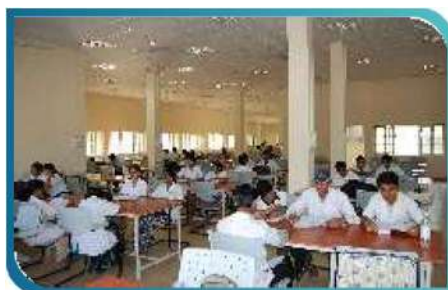


- All hostels have secure Wi-Fi internet connectivity, through high end firewall.

85 % seats are reserved under this category. The admission to this category will be made on the basis of inter-se merit of the candidates at PIMS-AICET-PG 2024.

#### b. FN (Foreign Nationals)/ PIO (Persons of Indian Origin)/ NRI (Non Resident Indians) Category:

15% seats are reserved under this Category. The Foreign National (FN), wards of Persons of Indian Origin (PIO) settled abroad and wards of Non Resident Indians (NRI) are eligible to apply under this category. Preference will be given to the foreign nationals and wards of PIO.

The merit of candidates seeking admission under this category will be decided by the PIMS University taking into consideration equivalence and recognition of the examination passed by the candidate and his academic performance i.e. marks / grade obtained by him. Candidates seeking admission under this category will have to apply separately to The Registrar, PIMS University.

If the Seats in FN/PIO/NRI Category remain vacant, these will be filled from the Indian Nationals on the basis of PIMS-AICET-PG 2024 merit of the candidates applied under Management/Paid Seats Quota.

### 4. Eligibility Criteria

## 11. Selection Process

Candidates who secure minimum 50% marks in PIMS-AICET-PG 2024 and satisfy the eligibility norms laid down by respective councils will be eligible for admission to M.P.TH., M.Sc. Nursing and M.Sc. Medical Biotechnology courses.

The admission will be offered only on the basis of PIMS-AICET-PG 2024 merit at the time of counseling. There is no reservation for backward class (SC/ST/NT/OBC etc.).

However, candidates will be called for counseling on the basis of their performance in PIMS-AICET-PG 2024 examination. The schedule of counseling will be displayed on official website of PIMS University i.e. <http://www.pravara.com>.

The selection of candidate will be made only on the merit basis of PIMS-AICET-PG 2024.

## 12. Counseling

- The representative should bring original documents for verification and prescribed fees.

- In case of any dispute in the matter of allocation/ admission or any other matter pertaining to the provisional selection or cancellation of admission, the decision of the Admission Committee will be final and binding on the candidate.



➤ **Scrutiny/ Verification of the Documents :**

- a. The candidate should report before 10.30 AM at counseling center on scheduled date for completing the process of scrutiny/ verification of original documents.
- b. The attendance of the candidates present for Scrutiny/ verification of documents will be recorded between 09.00 AM to 10.30 AM. If candidate fails to report before 10.30 AM, he/ she will be considered as absent for counseling and his/ her claim will not be entertained for admission process & subsequent rounds.

**GUIDELINES FOR ENTRANCE TEST****Regulations at the Test Center**

The examination hall will be opened 30 minutes before the commencement of the test. Candidate should occupy the seat with the allotted number. Candidate must carry Admit Card and produce it as and when demanded failing which, candidate will not be allowed to appear for the test. The candidates are required to sign the declaration on the answer sheet in the presence of the invigilator. At **09:45 AM** the candidates will receive an Answer Sheet. They must ensure that the Answer Sheet they have received is correct and properly printed on both sides. At **10:55 AM** the candidates will receive a Test Booklet for PIMS-AICET-PG 2024. They must ensure that the Test Booklet received by them is correct and printed properly. Each Test Booklet has a specific five-digit Test Booklet number which should be entered in the Answer Sheet and also darken circles of text booklet version at the appropriate place. No candidate will be allowed to enter the examination hall after **10:00 AM**. Candidates will have to remain seated in the examination hall till the completion of the duration of the test. Candidates are expected to maintain silence during the examination. Any conversation or gesticulation or disturbance in the examination hall shall be deemed as misbehavior.

The Admission Committee will take strict action against the candidates, who use unfair means or impersonation. Such candidates will be asked to leave the examination hall immediately and they will be liable to be debarred from examination either permanently or for specified period as decided by the PIMS University. The Admission Committee will reserve the right to withhold the result of such candidates.

Candidates have to put their Admit Card number in appropriate places on the answer sheet by ball point pen. All the entries of MCQ's made using a **HB Pencil/ Black Ballpoint Pen**. Wherever the entries have to be marked in the circles, it should be done by completely darkening the corresponding circles. The candidate will be solely responsible for writing the wrong Admit Card number and the Test Booklet number on the Answer Sheet. Candidates must stop marking the answer after the warning bell at the closing time. The candidate must ensure that the Admit Card Number and the Test Booklet Number are correctly written in the answer sheet. The answer sheets of the candidates who do not submit the Test Booklet will not be evaluated. Such candidates will be debarred from appearing the test in future. Candidates will not be allowed to carry any test material (printed or written) or any other material except the Admit Card inside the examination hall. Candidates are also not permitted to carry any device like calculator, cellular phone, pager, electronic gadgets etc. Smoking in the examination hall is strictly prohibited. Any kind of eatable or drink is not allowed in the examination hall.

**Marking of Answers**

Each Multiple Choice Question will have four responses labeled A,B,C and D. Candidates should indicate the correct or most appropriate answer by darkening the appropriate circle completely. The questions can also be in form of incomplete statements. The candidate should mark appropriately one of the four responses, which completes the statement.

If more than one circle is darkened or if the response is marked in any wrong manner other than circle it will be treated as wrong answer. Candidates must ensure that the Answer Sheet is not folded and make no stray marks on it. If pencils other than HB are used to mark the answers, the Optical Scanner can reject the Answer Sheet during scanning. Candidates must bring their own pencils, erasers and sharpeners. They are not allowed to take, borrow anything from the other candidates during examination. The order of questions is not the same in all Test Booklets and they are jumbled. Candidates should never change their Test Booklet during the test.

**Changing the Answer**

If a candidate wants to change any answer on his/her answer sheet, he/she must erase completely the existing pencil mark and then darken the appropriate circle with HB pencil/ Ballpoint pen.



### Rough Work

If a candidate wishes to do some rough work, the same should be done in the Test Booklet itself. It should not be done on the Answer Sheet.

### Scoring

Each question carries one mark. There is no negative marking. An answer marked incorrectly will be considered as a wrong answer. No request for revaluation or re-checking will be entertained.

### Vigilance

1. The University Observer / University Representatives appointed by PIMS University will...
  - a. Ensure that the AICET is conducted as per norms laid down by the PIMS University.
  - b. Observe whether the Center In charge, Senior Supervisor and Block Supervisors are following instructions for conduct of the AICET.
  - c. Identify the students who try to resort to malpractices at the time of AICET and report to University Authorities.
2. The University Observer is authorized to visit any Examination Center without prior intimation and enter office of the in charge of Examination Center to check the record and other material relating to the conduct of AICET. They can enter in any block of the Examination for checking the candidate's identity, Admit Cards etc. to ascertain the authenticity of the candidate. The university observer is authorized to detect use of malpractices and unfair means at the AICET Center; and if found guilty, University observer is authorized to expel such candidate from the examination block and report to the Admission Committee. The action taken by the University Observer will be final and binding on the candidate.

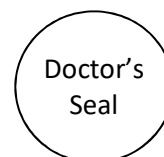

**UNIVERSITY GRANTS COMMISSION, NEW DELHI  
REGULATIONS ON CURBING THE MENACE OF RAGGING  
IN HIGHER EDUCATIONAL INSTITUTIONS, 2009**

NO.F 1-16/2007 (CPP-II)

Dated : 17<sup>th</sup> June, 2009**PREAMBLE**

In view of the directions of the Hon'ble Supreme Court in the matter of "University of Kerala v/s. Council, Principals, Colleges and others" in SLP no. 24295 of 2006 dated 28.05.2007 and that dated 8.05.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government and the University Grants Commission to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the University Grants Commission, in consultation with the Councils, brings forth this Regulation.

In exercise of the powers conferred by Clause (g) of sub-section (1) of Section 26 of the University Grants Commission Act, 1956, the University Grants Commission hereby makes the following regulations, namely;

**1. Title, commencement and applicability**

- 1.1 These regulations shall be called the "UGC regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009."
- 1.2 They shall come into force from the date of their publication in the Official Gazette.
- 1.3 They shall apply to all the institutions coming within the definition of an University under sub-section (f) of section (2) of the University Grants Commission Act, 1956, and to all institutions deemed to be a university under Section 3 of the University Grants Commission Act, 1956, to all other higher educational institutions, or elements of such universities or institutions, including its departments, constituent units and all the premises whether being academic, residential, playgrounds, canteen, or other such premises of such universities, deemed universities and higher educational institutions, whether located inside campus or outside, and to all means of transportation of students, whether public or private, accessed by students for the pursuit of studies in such universities, deemed universities and higher educational institutions.

**2. Objectives**

To prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student; and thereby, to eliminate ragging in all its forms from universities, deemed universities and other higher educational institutions in the country by prohibiting it under these Regulations, preventing its occurrence and punishing those who indulge in ragging as provided for in these Regulations and the appropriate law in force.

**3. What constitutes Ragging**

Ragging constitutes one or more of any of the following acts :

- a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b. indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;

- c. asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- d. any act by a senior student that prevents, disrupts or disturbs the regular, academic activity of any other student or a fresher;
- e. exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g. any act of physical abuse including all variants of it : sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h. any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student ;
- i. any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

#### 4. Definitions

- 1) In these regulations unless the context otherwise requires -
  - a) “Act” means, the University Grants Commission Act, 1956 (3 of 1956);
  - b) “Academic year” means the period from the commencement of admission of students in any course of study in the institution up to the completion of academic requirements for that particular year.
  - c) “Anti-Ragging Helpline” means the Helpline established under clause (a) of Regulation 8.1 of these Regulations.
  - d) “Commission” means the University Grants Commission;
  - e) “ Council” means a body so constituted by an Act of Parliament or an Act of any State Legislature for setting, or co-ordinating or maintaining students in the relevant areas of higher education, such as the All India Council for Technical Education (AICTE), the Bar Council of India (BCI), the Dental Council of India (DCI), the Distance Education Council (DEC), the Indian Council of Agricultural Research (ICAR), the Indian Nursing Council (INC), the Medical Council of India (MCI), the National Council of Teacher Education (NCTE), the Pharmacy Council of India (PCI),etc. and the State Higher Education Councils.
  - f) “District Level Anti-Ragging Committee” means the Committee, headed by the District Magistrate, constituted by the State Government, for the control and elimination of ragging in institutions within the jurisdiction of the district.
  - g) “Head of the institution” means the Vice-Chancellor in case of a university or a deemed to be university, the Principal or the Director or such other designation as the executive head of the institution or the college is referred.
  - h) “Fresher” means a student who has been admitted to an institution and who is undergoing his/her first year of study in such institution.
  - i) “Institution” means a higher educational institution including, but not limited to an university, a deemed to be university, a college, an institute, an institution of national importance set up by an Act of Parliament or a constituent unit of such institution, imparting higher education beyond 12 years of schooling leading to, but not necessarily culminating in, a degree (graduate, postgraduate and/or higher level) and/or to a university diploma.
  - j) “NAAC” means the National Assessment and Accreditation Council established by the Commission under section 12(ccc) of the Act; ,
  - k) “State Level Monitoring Cell” means the body constituted by the State Government for the control and elimination of ragging in institutions within the jurisdiction of the State, established under State Law or on the advice of the Central Government, as the case may be.
- 2) Words and expressions used and not defined herein but defined in the Act or in the General Clauses Act, 1897, shall have the meanings respectively assigned to them in the Act or in the General Clauses Act, 1897, as the case may be.

#### 5. Measures for prohibition of ragging at the institution level

- a) No institution or any part of it thereof, including, but not limited to, the departments, constituent units, colleges, centers of studies and all its premises, whether academic, residential, playgrounds, or canteen, whether located within the campus or outside, and in all means of transportation of



- students, whether public or private, accessed by students for the pursuit of studies in such institutions, shall permit or condone any reported incident of ragging in any form; and all institutions shall take all necessary and required measures, including but not limited to the provisions of these Regulations, to achieve the objective of eliminating ragging, within the institution or outside,
- b) All institutions shall take action in accordance with these Regulations against those found guilty of ragging and/or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.

## **6. Measures for prevention of ragging at the institution level**

### **6.1 An institution shall take the following steps in regard to admission or registration of students; namely,**

- a) Every public declaration of intent by any institution, in any electronic, audio-visual or print or any other media, for admission of students to any course of study shall expressly provide that ragging is totally prohibited in the institution, and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with these Regulations as well as under the provisions of any penal law for the time being in force.
- b) The brochure of admission / instruction booklet or the prospectus, whether in print or electronic format, shall prominently print these Regulations in full.

Provided that the institution shall also draw attention to any law concerning ragging and its consequences, as may be applicable to the institution publishing such brochure of admission / instruction booklet or the prospectus.

Provided further that the telephone numbers of the Anti-Ragging Helpline and all the important functionaries in the institution, including but not limited to the Head of the institution, faculty members, members of the Anti-Ragging Committees and Anti-Ragging Squads, District and Sub - Divisional authorities, Wardens of hostels, and other functionaries or authorities where relevant, shall be published in the brochure of admission/instruction booklet or the prospectus.

- a) Where an Institution is affiliated to a University and publishes a brochure of admission/instruction booklet or a prospectus, the affiliating university shall ensure that the affiliated institution shall comply with the provisions of clause (a) and clause (b) of Regulation 6.1 of these Regulations.
- d) The application form for admission, enrolment or registration shall contain an affidavit, mandatorily in English and in Hindi and/or in one of the regional languages known to the applicant, as provided in the English language in Annexure I to these Regulations, to be filled up and signed by the applicant to the effect that he/she has read and understood the provisions of these Regulations as well as the provisions of any other law for the time being in force, and is aware of the prohibition of ragging and the punishments prescribed, both under penal laws as well as under these Regulations and also affirm to the effect that he/she has not been expelled and/or debarred by any institution and further aver that he/she would not indulge, actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/or abetting ragging, is liable to be proceeded against under these Regulations or under any penal law or any other law for the time being in force and such action would include but is not limited to debarment or expulsion of such student.
- e) The application form for admission, enrolment or registration shall contain an affidavit, mandatorily in English and in Hindi and/or in one of the regional languages known to the parents/guardians of the applicant, as provided in the English language in Annexure II to these Regulations, to be filled up and signed by the parents/guardians of the applicant to the effect that he/she has read and understood the provisions of these Regulations as well as the provisions of any other law for the time being in force, and is aware of the prohibition of ragging and the punishments prescribed, both under penal laws as well as under these Regulations and also affirm to the effect that his/her ward has not been expelled; and/or debarred by any institution and further aver that his/her ward would not indulge, actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/or abetting ragging, his/her ward is liable to be proceeded against under these Regulations or under any penal law or any other law for the time being in force and such action would include but is not limited to debarment or expulsion of his/her ward.
- f) The application for admission shall be accompanied by a document in the form of, or annexed to, the School Leaving Certificate/Transfer Certificate/Migration Certificate/Character Certificate reporting on the inter-personal/social behavioral pattern of the applicant, to be issued by the school or institution last attended by the applicant, so that the institution can thereafter keep watch on the applicant, if admitted, whose behavior has been commented in such document.
- g) A student seeking admission to a hostel forming part of the institution, or seeking to reside in any temporary premises not forming part of the institution, including a private commercially managed

lodge or hostel, shall have to submit additional affidavits countersigned by his/ her parents/guardians in the form prescribed in Annexure I and Annexure II to these Regulations respectively along with his/her application.

- h) Before the commencement of the academic session in any institution, the Head of the Institution shall convene and address a meeting of various functionaries/agencies, such as Hostel Wardens, representatives of students, parents/ guardians, faculty, district administration including the police, to discuss the measures to be taken to prevent ragging in the institution and steps to be taken to identify those indulging in or abetting ragging and punish them.
- i) The institution shall, to make the community at large and the students in particular aware of the dehumanizing effect of ragging, and the approach of the institution towards those indulging in ragging, prominently display posters depicting the provisions of penal law applicable to incidents of ragging, and the provisions of these Regulations and also any other law for the time being in force, and the punishments thereof, shall be prominently displayed on Notice Boards of all departments, hostels and other buildings as well as at places, where students normally gather and at places, known to be vulnerable to occurrences of ragging incidents.
- j) The institutions shall request the media to give adequate publicity to the law prohibiting ragging and the negative aspects of ragging and the institution's resolve to ban ragging and punish those found guilty without fear or favour.
- k) The institution shall identify, properly illuminate and keep a close watch on all locations known to be vulnerable to occurrences of ragging incidents.
- l) The institution shall tighten security in its premises, especially at vulnerable places and intense policing by Anti-Ragging Squad, referred to in these Regulations and volunteers, if any, shall be resorted to at such points at odd hours during the first few months of the academic session.
- m) The institution shall utilize the vacation period before the start of the new academic year to launch a publicity campaign against ragging through posters, leaflets and such other means, as may be desirable or required, to promote the objectives of these regulations.
- n) The faculties/departments/units of the institution shall have induction arrangements, including those which anticipate, identify and plan to meet any special needs of any specific section of students, in place well in advance of the beginning of the academic year with an aim to promote the objectives of this Regulation.
- o) Every institution shall engage or seek the assistance of professional counsellors before the commencement of the academic session, to be available when required by the institution, for the purposes of offering counseling to fresher's and to other students after the commencement of the academic year.
- p) The head of the institution shall provide information to the local police and local authorities, the details of every privately commercially managed hostels or lodges used for residential purposes by students enrolled in the institution and the head of the institution shall also ensure that the Anti-Ragging Squad shall ensure vigil in such locations to prevent the occurrence of ragging therein.

**6.2 An institution shall, on admission or enrolment or registration of students, take the following steps, namely;**

- a) Every fresh student admitted to the institution shall be given a printed leaflet detailing to whom he/she has to turn to for help and guidance for various purposes including addresses and telephone numbers, so as to enable the student to contact the concerned person at any time, if and when required, of the Anti-Ragging Helpline referred to in these Regulations, Wardens, Head of the institution, all members of the anti-ragging squads and committees, relevant district and police authorities;
- b) The institution, through the leaflet specified in clause (a) of Regulation 6.2 of these Regulations shall explain to the fresher's, the arrangements made for their induction and orientation which promote efficient and effective means of integrating them fully as students with those already admitted to the institution in earlier years.
- c) The leaflet specified in clause (a) of Regulation 6.2 of these Regulations shall inform the fresher's about their rights as bona fide students of the institution and clearly instructing them that they should desist from doing anything, with or against their will, even if ordered to by the senior students, and that any attempt of ragging shall be promptly reported to the Anti-ragging Squad or to the Warden or to the Head of the institution, as the case may be.
- d) The leaflet specified in clause (a) of Regulation 6.2 of these Regulations shall contain a calendar of events and activities laid down by the institution to facilitate and complement familiarization of fresher's with the academic environment of the institution.

- e) The institution shall, on the arrival of senior students after the first week or after the second week, as the case may be, schedule orientation programmes as follows, namely; (i) joint sensitization programme and counseling of both Fresher's and senior students by a professional counsellor, referred to in clause (o) of Regulation 6.1 of these Regulations; (ii) joint orientation programme of Fresher's and seniors to be addressed by the Head of the institution and the anti-ragging committee; (iii) organization on a large scale of cultural, sports and other activities to provide a platform for the fresher's and seniors to interact in the presence of faculty members ; (iv) in the hostel, the warden should address all students; and may request two junior colleagues from the college faculty to assist the warden by becoming resident tutors for a temporary duration. (v) as far as possible faculty members should dine with the hostel residents in their respective hostels to instill a feeling of confidence among the Fresher's.
- f) The institution shall set up appropriate committees, including the course-in-charge, student advisor, Wardens and some senior students as its members, to actively monitor, promote and regulate healthy interaction between the Fresher's, junior students and senior students.
- g) Fresher's or any other student(s), whether being victims, or witnesses, in any incident of ragging, shall be encouraged to report such occurrence, and the identity of such informants shall be protected and shall not be subject to any adverse consequence only for the reason for having reported such incidents.
- h) Each batch of Fresher's, on arrival at the institution, shall be divided into small groups and each such group shall be assigned to a member of the faculty, who shall interact individually with each member of the group every day for ascertaining the problems or difficulties, if any, faced by the fresher in the institution and shall extend necessary help to the fresher in overcoming the same.
- i) It shall be the responsibility of the member of the faculty assigned to the group of Fresher's, to coordinate with the Wardens of the hostels and to make surprise visits to the rooms in such hostels, where a member or members of the group are lodged; and such member of faculty shall maintain a diary of his/her interaction with the Fresher's under his/her charge.
- j) Fresher's shall be lodged, as far as may be, in a separate hostel block, and where such facilities are not available, the institution shall, ensure that access of seniors to accommodation allotted to Fresher's is strictly monitored by wardens, security guards and other staff of the institution.
- k) A round the clock vigil against ragging in the hostel premises, in order to prevent ragging in the hostels after the classes are over, shall be ensured by the institution.
- l) It shall be the responsibility of the parents/guardians of Fresher's to promptly bring any instance of ragging to the notice of the Head of the Institution.
- m) Every student studying in the institution and his / her parents / guardians shall provide the specific affidavits required under clauses (d), (e) and (g) of Regulation 6.1 of these Regulations at the time of admission or registration, as the case may be, during each academic year.
- n) Every institution shall obtain the affidavit from every student as referred to above in clause (m) of Regulation 6.2 and maintain a proper record of the same and to ensure its safe upkeep thereof, including maintaining the copies of the affidavit in an electronic form, to be accessed easily when required either by the Commission; or any of the Councils or by the institution or by the affiliating University or by any other person or organization authorized to do so.
- o) Every student at the time of his/her registration shall inform the institution about his/her place of residence while pursuing the course of study, and in case the student has not decided his/her place of residence or intends to change the same, the details of his place of residence shall be provided immediately on deciding the same; and specifically in regard to a private commercially managed lodge or hostel where he/she has taken up residence.
- p) The Head of the institution shall, on the basis of the information provided by the student under clause (o) of Regulation 6.2, apportion sectors to be assigned to members of the faculty, so that such member of faculty can maintain vigil and report any incident of ragging outside the campus or en route while commuting to the institution using any means of transportation of students, whether public or private.
- q) The Head of institution shall, at the end of each academic year, send a letter to the parents/guardians of the students who are completing their first year in the institution, informing them about these Regulations and any law for the time being in force prohibiting ragging and the punishments thereof as well as punishments prescribed under the penal laws, and appealing to them to impress upon their wards to desist from indulging in ragging on their return to the institution at the beginning of the academic session next.

### **6.3 Every institution shall constitute the following bodies; namely,**

- a) Every institution shall constitute a Committee to be known as the Anti-Ragging Committee to be nominated and headed by the Head of the institution, and consisting of representatives of civil and police

administration, local media, Non-Government Organizations involved in youth activities, representatives of faculty members, representatives of parents, representatives of students belonging to the Fresher's' category as well as senior students, non-teaching staff; and shall have a diverse mix of membership in terms of levels as well as gender.

- b) It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
- c) Every institution shall also constitute a smaller body to be known as the Anti Ragging Squad to be nominated by the Head of the Institution with such representation as may be considered necessary for maintaining vigil, oversight and patrolling function and shall remain mobile, alert and active at all times. Provided that the Anti-Ragging Squad shall have representation of various members of the campus community and shall have no outside representation.
- d) It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise raids on hostels, and other places vulnerable to incidents of, and having the potential of, ragging and shall be empowered to inspect such places.
- e) It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incident of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendation shall be submitted to the Anti-Ragging Committee for action under clause (a) of Regulation 9.1.  
Provided that the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required.
- f) Every institution shall, at the end of each academic year, in order to promote the objectives of these regulations, constitute a Mentoring Cell consisting of students volunteering to be Mentors for Fresher's, in the succeeding academic year; and there shall be as many levels or tiers of Mentors as the number of batches in the institution, at the rate of one Mentor for six Fresher's and one Mentor of a higher level for six Mentors of the lower level.
- g) Every University shall constitute a body to be known as Monitoring Cell on Ragging, which shall coordinate with the affiliated colleges and institutions under the domain of the University to achieve the objectives of these Regulations; and the Monitoring Cell shall call for reports from the Heads of institutions in regard to the activities of the Anti-Ragging Committees, Anti - Ragging Squads, and the Mentoring Cells at the institutions, and it shall also keep itself abreast of the decisions of the District level Anti-Ragging Committee headed by the District Magistrate.
- h) The Monitoring Cell shall also review the efforts made by institutions to publicize anti-ragging measures, soliciting of affidavits from parents/guardians and from students, each academic year, to abstain from ragging activities or willingness to be penalized for violations; and shall function as the prime mover for initiating action on the part of the appropriate authorities of the university for amending the Statutes or Ordinances or Bye-laws to facilitate the implementation of anti-ragging measures at the level of the institution.

**6.4 Every institution shall take the following other measures, namely;**

- a) Each hostel or a place where groups of students reside, forming part of the institution, shall have a full-time Warden, to be appointed by the institution as per the eligibility criteria laid down for the post reflecting both the command and control aspects of maintaining discipline and preventing incidents of ragging within the hostel, as well as the softer skills of counseling and communicating with the youth outside the class-room situation; and who shall reside within the hostel, or at the very least, in the close vicinity thereof.
- b) The Warden shall be accessible at all hours and be available on telephone and other modes of communication, and for the purpose the Warden shall be provided with a mobile phone by the institution, the number of which shall be publicized among all students residing in the hostel.
- c) The institution shall review and suitably enhance the powers of Wardens; and the security personnel posted in hostels shall be under the direct control of the Warden and their performance shall be assessed by them.
- d) The professional counselors referred to under clause (o) of Regulation 6.1 of these Regulations shall, at the time of admission, counsel fresher's and/or any other student(s) desiring counseling, in order



to prepare them for the life ahead, particularly in regard to the life in hostels and to the extent possible, also involve parents and teachers in the counseling sessions.

- e) The institution shall undertake measures for extensive publicity against ragging by means of audio-visual aids, counseling sessions, workshops, painting and design competitions among students and such other measures, as it may deem fit.
- f) In order to enable a student or any person to communicate with the Anti Ragging Helpline, every institution shall permit unrestricted access to mobile phones and public phones in hostels and campuses, other than in class-rooms, seminar halls, library, and in such other places that the institution may deem it necessary to restrict the use of phones.
- g) The faculty of the institution and its non-teaching staff, which includes but is not limited to the administrative staff, contract employees, security guards and employees of service providers providing services within the institution, shall be sensitized towards the ills of ragging, its prevention and the consequences thereof.
- h) The institution shall obtain an undertaking from every employee of the institution including all teaching and non-teaching members of staff, contract labors employed in the premises either for running canteen or as watch and ward staff or for cleaning or maintenance of the buildings/lawns and employees of service providers providing services within the institution, that he/she would report promptly any case of ragging which comes to his/her notice.
- i) The institution shall make a provision in the service rules of its employees for issuing certificates of appreciation to such members of the staff who report incidents of ragging, which will form part of their service record.
- j) The institution shall give necessary instructions to the employees of the canteens and messing, whether that of the institution or that of a service provider providing this service, or their employers, as the case may be, to keep a strict vigil in the area of their work and to report the incidents of ragging to the Head of the institution or members of the Anti-Ragging Squad or members of the Anti-Ragging Committee or the Wardens, as may be required.
- k) All Universities awarding a degree in education at any level, shall be required to ensure that institutions imparting instruction in such courses or conducting training programme for teachers include inputs relating to anti-ragging and the appreciation of the relevant human rights, as well as inputs on topics regarding sensitization against corporal punishments and checking of bullying amongst students, so that every teacher is equipped to handle at least the rudiments of the counseling approach.
- l) Discreet random surveys shall be conducted amongst the fresher's every fortnight during the first three months of the academic year to verify and cross-check whether the institution is indeed free of ragging or not and for the purpose the institution may design its own methodology of conducting such surveys.
- m) The institution shall cause to have an entry, apart from those relating to general conduct and behavior, made in the Migration/Transfer Certificate issued to the student while leaving the institution, as to whether the student has been punished for committing or abetting an act of ragging, as also whether the student has displayed persistent violent or aggressive behavior or any inclination to harm others, during his course of study in the institution.
- n) Notwithstanding anything contained in these Regulations with regard to obligations and responsibilities pertaining to the authorities or members of bodies prescribed above, it shall be the general collective responsibility of all levels and sections of authorities or functionaries including members of the faculty and employees of the institution, whether regular or temporary, and employees of service providers providing service within the institution, to prevent or to act promptly against the occurrence of ragging or any incident of ragging which comes to their notice.
- o) The Heads of institutions affiliated to a University or a constituent of the university, as the case may be, shall, during the first three months of an academic year, submit a weekly report on the status of compliance with Anti Ragging measures under these Regulations, and a monthly report on such status thereafter, to the Vice-Chancellor of the University to which the institution is affiliated to or recognized by.
- p) The Vice Chancellor of each University, shall submit fortnightly reports of the University, including those of the Monitoring Cell on Ragging in case of an affiliating university, to the State Level Monitoring Cell.

## **7. Action to be taken by the Head of the institution**

On receipt of the recommendation of the Anti-Ragging Squad or on receipt of any information concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

- i. Abetment to ragging;
- ii. Criminal conspiracy to rag;
- iii. Unlawful assembly and rioting while ragging;
- iv. Public nuisance created during ragging;
- v. Violation of decency and morals through ragging;
- vi. Injury to body, causing hurt or grievous hurt;
- vii. Wrongful restraint;
- viii. Wrongful confinement;
- ix. Use of criminal force;
- x. Assault as well as sexual offences or unnatural offences;
- xi. Extortion;
- xii. Criminal trespass;
- xiii. Offences against property;
- xiv. Criminal intimidation;
- xv. Attempts to commit any or all of the above mentioned offences against the victim(s);
- xvi. Threat to commit any or all of the above mentioned offences against the victim(s);
- xvii. Physical or psychological humiliation;
- xviii. All other offences following from the definition of "Ragging".

Provided that the Head of the institution shall forthwith report the occurrence of the incident of ragging to the District Level Anti-Ragging Committee and the Nodal officer of the affiliating University, if the institution is an affiliated institution.

Provided further that the institution shall also continue with its own enquiry initiated under clause 9 of these Regulations and other measures without waiting for action on the part of the police/local authorities and such remedial action shall be initiated and completed immediately and in no case later than a period of seven days of the reported occurrence of the incident of ragging.

## **8. Duties and Responsibilities of the Commission and the Councils**

**8.1 The Commission shall, with regard to providing facilitating communication of information regarding incidents of ragging in any institution, take the following steps, namely;**

- a) The Commission shall establish, fund and operate, a toll-free Anti-Ragging Helpline, operational round the clock, which could be accessed by students in distress owing to ragging related incidents.
- b) Any distress message received at the Anti-Ragging Helpline shall be simultaneously relayed to the Head of the Institution, the Warden of the Hostels, the Nodal Officer of the affiliating University, if the incident reported has taken place in an institution affiliated to a University, the concerned District authorities and if so required, the District Magistrate, and the Superintendent of Police, and shall also be web enabled so as to be in the public domain simultaneously for the media and citizens to access it.
- c) The Head of the institution shall be obliged to act immediately in response to the information received from the Anti-Ragging Helpline as at sub-clause (b) of this clause.
- d) The telephone numbers of the Anti-Ragging Helpline and all the important functionaries in every institution, Heads of institutions, faculty members, members of the anti-ragging committees and anti-ragging squads, district and sub-divisional authorities and state authorities, Wardens of hostels, and other functionaries or authorities, where relevant, shall be widely disseminated for access or to seek help in emergencies.
- e) The Commission shall maintain an appropriate data base to be created out of affidavits, affirmed by each student and his/her parents/guardians and stored electronically by the institution, either on its or through an agency to be designated by it; and such database shall also function as a record of ragging complaints received, and the status of the action taken thereon.
- f) The Commission shall make available the database to a non-governmental agency to be nominated by the Central Government, to build confidence in the public and also to provide information of non-compliance

with these Regulations to the Councils and to such bodies as may be authorized by the Commission or by the Central Government.

**8.2 The Commission shall take the following regulatory steps, namely;**

- a) The Commission shall make it mandatory for the institutions to incorporate in their prospectus, the directions of the Central Government or the State Level Monitoring Committee with regard to prohibition and consequences of ragging, and that non-compliance with these Regulations and directions so provided, shall be considered as lowering of academic standard by the institution, therefore making it liable for appropriate action.
- b) The Commission shall verify that the institutions strictly comply with the requirement of getting the affidavits from the students and their parents/guardians as envisaged under these Regulations.
- c) The Commission shall include a specific condition in the Utilization Certificate, in respect of any financial assistance or grants-in-aid to any institution under any of the general or special schemes of the Commission that the institution has complied with the anti-ragging measures.
- d) Any incident of ragging in an institution shall adversely affect its accreditation, ranking or grading by NAAC or by any other authorized accreditation agencies while assessing the institution for accreditation, ranking or grading purposes.
- e) The Commission may accord priority in financial grants-in-aid to those institutions, otherwise eligible to receive grants under section 12B of the Act, which report a blemish less record in terms of there being no reported incident of ragging.
- f) The Commission shall constitute an Inter-Council Committee, consisting of representatives of the various Councils, the Non-Governmental agency responsible for monitoring the database maintained by the Commission under clause (g) of Regulation 8.1 and such other bodies in higher education, to coordinate and monitor the anti-ragging measures in institutions across the country and to make recommendations from time to time; and shall meet at least once in six months each year.
- g) The Commission shall institute an Anti-Ragging Cell within the Commission as an institutional mechanism to provide secretarial support for collection of information and monitoring, and to coordinate with the State Level Monitoring Cell and University level Committees for effective implementation of anti-ragging measures, and the Cell shall also coordinate with the Non-Governmental agency responsible for monitoring the database maintained by the Commission appointed under clause (g) of Regulation 8.1.

**9. Administrative action in the event of ragging**

**9.1 The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under:**

- a) The Anti-Ragging Committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:
  - i. Suspension from attending classes and academic privileges.
  - ii. Withholding/ withdrawing scholarship/ fellowship and other benefits.
  - iii. Debarring from appearing in any test/ examination or other evaluation process.
  - iv. Withholding results.
  - v. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
  - vi. Suspension/ expulsion from the hostel.
  - vii. Cancellation of admission.
  - viii. Rustication from the institution for period ranging from one to four semesters.
  - ix. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

- c) An appeal against the order of punishment by the Anti - Ragging Committee shall lie,
  - i. in case of an order of an institution, affiliated to or constituent part, of a University, to the Vice-Chancellor of the University;

- ii. in case of an order of a University, to its Chancellor.
- iii. in case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be.

**9.2 Where an institution, being constituent of, affiliated to or recognized by a University, fails to comply with any of the provisions of these Regulations or fails to curb ragging effectively, such University may take any one or more of the following actions, namely;**

- i. Withdrawal of affiliation/recognition or other privileges conferred.
- ii. Prohibiting such institution from presenting any student or students then undergoing any programme of study therein for the award of any degree / diploma of the University. Provided that where an institution is prohibited from presenting its student or students, the Commission shall make suitable arrangements for the other students so as to ensure that such students are able to pursue their academic studies.
- iii. Withholding grants allocated to it by the university, if any
- iv. Withholding any grants channelized through the university to the institution.
- v. Any other appropriate penalty within the powers of the university.

**9.3 Where in the opinion of the appointing authority, a lapse is attributable to any member of the faculty or staff of the institution, in the matter of reporting or taking prompt action to prevent an incident of ragging or who display an apathetic or insensitive attitude towards complaints of ragging, or who fail to take timely steps, whether required under these Regulations or otherwise, to prevent an incident or incidents of ragging, then such authority shall initiate departmental disciplinary action, in accordance with the prescribed procedure of the institution, against such member of the faculty or staff.**

Provided that where such lapse is attributable to the Head of the institution, the authority designated to appoint such Head shall take such departmental disciplinary action; and such action shall be without prejudice to any action that may be taken under the penal laws for abetment of ragging for failure to take timely steps in the prevention of ragging or punishing any student found guilty of ragging.

**9.4 The Commission shall, in respect of any institution that fails to take adequate steps to prevent ragging or fails to act in accordance with these Regulations or fails to punish perpetrators or incidents of ragging suitably, take one or more of the following measures, namely;**

- i. Withdrawal of declaration of fitness to receive grants under section 12B of the Act.
- ii. Withholding any grant allocated.
- iii. Declaring the institution ineligible for consideration for any assistance under any of the general or special assistance programmes of the Commission.
- iv. Informing the general public, including potential candidates for admission, through a notice displayed prominently in the newspapers or other suitable media and posted on the website of the Commission, declaring that the institution does not possess the minimum academic standards.
- v. Taking such other action within its powers as it may deem fit and impose such other penalties as may be provided in the Act for such duration of time as the institution complies with the provisions of these Regulations.

Provided that the action taken under this clause by the Commission against any institution shall be shared with all Councils.

## **UNIVERSITY GRANTS COMMISSION NOTIFICATION**

New Delhi, the 11th April, 2023

### **University Grants Commission (Redressal of Grievances of Students) Regulations, 2023**

**F.1-13/2022 (CPP-II).**— In exercise of the powers conferred under clause (g) of sub-section (1) of Section 26 of the University Grants Commission Act, 1956 (3 of 1956), and in supersession of the University Grants Commission (Redress of Grievances of Students) Regulations, 2019, the University Grants Commission hereby makes the following regulations, namely -

#### **1. SHORT TITLE, APPLICATION, AND COMMENCEMENT :**

- These regulations shall be called as the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023.
- They shall apply to all higher education institutions, whether established or incorporated by or under a Central Act or a State Act, and every institution recognized by the University Grants Commission under clause (f) of Section 2 of the University Grants Commission Act, 1956 and to all institutions deemed to be a University declared as such under Section 3 therein and to all higher education institutions affiliated to a University.
- They shall come into force from the date of their publication in the Official Gazette.

#### **2. OBJECTIVE :**

To provide opportunities for redressal of certain grievances of students already enrolled in any institution, as well as those seeking admission to such institutions, and a mechanism thereto.

#### **3. DEFINITION :**

(1) In these regulations, unless the context otherwise requires-

- "Act" means the University Grants Commission Act, 1956 (3 of 1956);
- "Aggrieved student" means a student, who has any complaint in the matters relating to or connected with the grievances defined under these regulations.
- "college" means any institution, so defined in clause (b) of sub-section (1) of section 12A of the Act.
- "Commission" means the University Grants Commission established under section 4 of the UGC Act, 1956.
- "declared admission policy" means such policy, including the process there under, for admission to a course or program of study as may be offered by the institution by publication in the prospectus of the institution.
- "grievance" means, and includes, complaint(s) made by an aggrieved student in respect of the following, namely:
  - admission contrary to merit determined in accordance with the declared admission policy of the institution;
  - irregularity in the process under the declared admission policy of the institution;
  - refusal to admit in accordance with the declared admission policy of the institution;
  - non-publication of a prospectus by the institution, in accordance with the provisions of these regulations;
  - publication by the institution of any information in the prospectus, which is false or misleading, and not based on facts;
  - withholding of, or refusal to return, any document in the form of certificates of degree, diploma or any other award or other document deposited by a student for the purpose of seeking admission in such institution, with a view to induce or compel such student to pay any fee or fees in respect of any course or program of study which such student does not intend to pursue;
  - demand of money in excess of that specified to be charged in the declared admission policy of the institution;
  - violation, by the institution, of any law for the time being in force in regard to reservation of seats in admission to

- different category of students;
- ix. non-payment or delay in payment of scholarships or financial aid admissible to any student under the declared admission policy of such institution, or under the conditions, if any, prescribed by the Commission;
- x. delay by the institution in the conduct of examinations, or declaration of results, beyond the schedule specified in the academic calendar of the institution, or in such calendar prescribed by the Commission;
- xi. failure by the institution to provide student amenities as set out in the prospectus, or is required to be extended by the institution under any provisions of law for the time being in force;
- xii. non-transparent or unfair practices adopted by the institution for the evaluation of students;
- xiii. delay in, or denial of, the refund of fees due to a student who withdraws admission within the time mentioned in the prospectus, subject to guidelines, if any, issued by the Commission, from time to time;
- xiv. complaints of alleged discrimination of students from the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Women, Minorities or persons with disabilities categories;
- xv. denial of quality education as promised at the time of admission or required to be provided;
- xvi. harassment or victimization of a student, other than cases of harassment, which are to be proceeded against under the penal provisions of any law for the time being in force;
- xvii. any action initiated/taken contrary to the statutes, ordinances, rules, regulations, or guidelines of the institution; and
- xviii. any action initiated/taken contrary to the regulations and/or guidelines made/issued by the Commission and/or the regulatory body concerned.
- (g) "Institution" means a university as defined in sub-section (f) of Section 2 of the UGC Act, an institution declared as institution deemed to be university under Section 3 of the Act, and a college as defined under section 12A (1) (b) of the University Grants Commission Act, 1956.
- (h) "Ombudsperson" means the Ombudsperson appointed under these regulations;
- (i) "Prospectus" means and includes any publication, whether in print or otherwise, issued for providing fair and transparent information, relating to an institution, to the general public (including to those seeking admission in such institution) by such institution or any authority or person authorized by such institution to do so;
- (j) "Student" means a person enrolled, or seeking admission to be enrolled, in any institution, to which these regulations apply, through any mode i.e., Formal / Open and Distance Learning (ODL) / Online;
- (k) "Students' Grievance Redressal Committee (SGRC)" means a committee constituted under these regulations, at the level of an institution; and
- (l) "University" means a University so defined in clause (f) of section 2 of the Act or, where the context may be, an institution deemed to be University declared as such under Section 3 thereof.
- (2) Words and expressions used and not defined in these regulations but defined in the University Grants Commission Act, 1956 shall have the same meanings as respectively assigned to them in the Act.

#### **4. MANDATORY PUBLICATION OF PROSPECTUS, ITS CONTENTS, AND PRICING:**

- (1) Every institution, shall publish and/or upload on its website, before expiry of at least sixty days prior to the date of the commencement of the admission to any of its courses or programs of study, a prospectus containing the following for the information of persons intending to seek admission to such institution and the general public, namely:
  - (a) the list of programs of study and courses offered along with the broad outlines of the syllabus specified by the appropriate statutory authority or by the institution, as the case may be, for every course or program of study, including teaching hours, practical sessions and other assignments;
  - (b) the number of seats approved by the appropriate statutory authority in respect of each course or program of study for the academic year for which admission is proposed to be made;
  - (c) the conditions of educational qualifications and eligibility including the minimum and maximum age limit of persons for admission as a student in a particular course or program of study, specified by the institution;
  - (d) the process of selection of eligible candidates applying for such admission, including all relevant information in regard to the details of test or examination for selecting such candidates for admission to each course or program of study and the amount of fee prescribed for the admission test;
  - (e) each component of the fee, deposits and other charges payable by the students admitted to such institution for pursuing a course or program of study, and the other terms and conditions of such payment;
  - (f) rules/regulations for imposition and collection of any fines in specified heads or categories, minimum and maximum fines may be imposed;
  - (g) the percentage of tuition fee and other charges refundable to a student admitted in such institution in case such student withdraws from such institution before or after completion of course or program of study and the time within and the manner in which such refund shall be made to that student;
  - (h) details of the teaching faculty, including their educational qualifications, along with their type of appointment (Regular/visiting/guest) and teaching experience of every member thereof;
  - (i) information with regard to physical and academic infrastructure and other facilities including hostel accommodation and its fee, library, hospital, or industry wherein the practical training is to be imparted to the students and in particular the amenities accessible by students on being admitted to the institution;

- (j) all relevant instructions in regard to maintaining the discipline by students within or outside the campus of the institution, and, in particular such discipline relating to the prohibition of ragging of any student or students and the consequences thereof and for violating the provisions of any regulation in this behalf made by the relevant statutory regulatory authority; and
  - (k) Any other information as may be specified by the Commission.
- Provided that an institution shall publish/upload information referred to in clauses (a) to (k) of this regulation, on its website, and the attention of prospective students and the general public shall be drawn to such publication being on the website through advertisements displayed prominently in different newspapers and through other media.
- (2) Every institution shall fix the price of each printed copy of the prospectus, being not more than the reasonable cost of its publication and distribution and no profit be made out of the publication, distribution, or sale of prospectus.

#### **6. STUDENT GRIEVANCE REDRESSAL COMMITTEES (SGRC):**

- (i) A complaint from an aggrieved student relating to the institution shall be addressed to the Chairperson, Students' Grievance Redressal Committee (SGRC).
- (ii) Every Institution shall constitute such number of Students' Grievance Redressal Committees (SGRC), as maybe required to consider grievances of the students, with the following composition, namely:
  - a) A Professor - Chairperson
  - b) Four Professors/Senior Faculty Members of the Institution as Members.
  - c) A representative from among students to be nominated on academic merit/excellence in sports/performance in co-curricular activities-Special Invitee.
- (iii) At least one member or the Chairperson shall be a woman and atleast one member or the Chairperson shall be from SC/ST/OBC category.
- (iv) The term of the chairperson and members shall be for a period of two years.
- (v) The term of the special invitee shall be one year.
- (vi) The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
- (vii) In considering the grievances before it, the SGRC shall follow principles of natural justice.
- (viii) The SGRC shall send its report with recommendations, if any, to the competent authority of the institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.
- (ix) Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.

#### **7. APPOINTMENT, TENURE, REMOVAL AND CONDITIONS OF SERVICES OF OMBUDSPERSON :**

- (i) Each University shall appoint Ombudsperson for redressal of grievances of students of the university and colleges/institutions affiliated with the university under these regulations.
- (ii) There shall be one or more part-time functionaries designated as Ombudspersons to hear, and decide on, appeals preferred against the decisions of the SGRCs.
- (iii) The Ombudsperson shall be a retired Vice-Chancellor or a retired Professor (who has worked as Dean/HOD) and has 10 years' experience as a Professor at State/Central Universities/Institutions of National Importance/Deemed to be Universities or a former District Judge.
- (iv) The Ombudsperson shall not, at the time of appointment, during one year before appointment, or in the course of his/her tenure as Ombudsperson, be in conflict of interest with the Institution where his/her personal relationship, professional affiliations or financial interest may compromise or reasonably appear to compromise, the independence of judgment towards the Institution.
- (v) The Ombudsperson shall be appointed for a period of three years or until he/she attains the age of 70 years, whichever is earlier, from the date of assuming office, and shall be eligible for reappointment for another one term.
- (vi) For conducting the hearings, the Ombudsperson shall be paid a sitting fee, per diem, in accordance with the norms fixed by the respective university and shall, in addition, be eligible for reimbursement of the expenditure incurred on conveyance.
- (vii) The University may remove the Ombudsperson from office, on charges of proven misconduct or misbehavior.
- (viii) No order of removal of Ombudsperson shall be made except after an inquiry made in this regard by a person, not below the rank of a retired judge of the High Court in which a reasonable opportunity of being heard is given to the Ombudsperson.

#### **8. FUNCTIONS OF OMBUDSPERSON :**

- (i) The Ombudsperson shall hear appeals from an aggrieved student, only after the student has availed all other remedies provided under these regulations.
- (ii) While issues of malpractices in the conduct of examination or in the process of evaluation may be referred to the Ombudsperson, no appeal or application for revaluation or re-totaling of answer sheets from an examination, shall be entertained by the Ombudsperson unless specific irregularity materially affecting the outcome or specific instance of discrimination is indicated.

- (iii) The Ombudsperson may avail assistance of any person, as amicus curiae, for hearing complaints of alleged discrimination.
- (iv) The Ombudsperson shall make all efforts to resolve the grievances within a period of 30 days of receiving the appeal from the aggrieved student(s).

#### **9. PROCEDURE FOR REDRESSAL OF GRIEVANCES BY OMBUDSPERSONS AND STUDENT GRIEVANCE REDRESSAL COMMITTEES:**

- (i) Each institution shall, within a period of three months from the date of issue of this notification, have an online portal where any aggrieved student may submit an application seeking redressal of grievance.
- (ii) On receipt of an online complaint, the institution shall refer the complaint to the appropriate Students' Grievance Redressal Committee, along with its comments within 15 days of receipt of complaint on the online portal.
- (iii) The Students' Grievance Redressal Committee, as the case may be, shall fix a date for hearing the complaint which shall be communicated to the institution and the aggrieved student.
- (iv) An aggrieved student may appear either in person or authorize a representative to present the case.
- (v) Grievances not resolved by the Students' Grievance Redressal Committee within the time period provided in these regulations may be referred to the Ombudsperson by the university.
- (vi) Institutions shall extend co-operation to the Ombudsperson or the Student Grievance Redressal Committee(s), in early redressal of grievances.
- (vii) The Ombudsperson shall, after giving reasonable opportunities of being heard to the parties concerned, on the conclusion of proceedings, pass such order, with reasons thereof, as may be deemed fit to redress the grievance and provide such relief as may be appropriate to the aggrieved student.
- (viii) The institution, as well as the aggrieved student, shall be provided with copies of the order under the signature of the Ombudsperson.
- (ix) The institution shall comply with the recommendations of the Ombudsperson.
- (x) The Ombudsperson may recommend appropriate action against the complainant, where a complaint is found to be false or frivolous.

#### **10. INFORMATION REGARDING OMBUDSPERSONS AND STUDENT GRIEVANCE REDRESSAL COMMITTEES:**

An institution shall furnish, prominently, on its website and in its prospectus, all relevant information in respect of the Students' Grievance Redressal Committee(s) coming in its purview, and the Ombudsperson for the purpose of appeals.

#### **11. CONSEQUENCES OF NON-COMPLIANCE :**

The Commission shall in respect of any institution, which willfully contravenes these regulations or repeatedly fails to comply with the recommendation of the Ombudsperson or the Students' Grievance Redressal Committee, as the case may be, proceed to take one or more of the following actions till the institution complies with these Regulations to the satisfaction of the Commission, namely:

- (a) withdrawal of declaration of fitness to receive grants under section 12 B of the Act;
- (b) withholding any grant allocated to the Institution;
- (c) declaring the institution ineligible for consideration for any assistance under any of the general or special assistance programs of the Commission;
- (d) declaring the institution ineligible to offer courses through Online/ODL mode for a specified period;
- (e) withdrawing / withholding / suspending the approval for offering courses through Online/ODL mode;
- (f) informing the general public, including potential candidates for admission, through a notice displayed prominently in suitable media and posted on the website of the Commission, declaring that the institution does not possess the minimum standards for redressal of grievances;
- (g) recommend to the affiliating University for withdrawal of affiliation, in case of a college;
- (h) take such action as it may deem necessary, appropriate and fit, in case of an institution deemed to be University;
- (i) recommend to the Central Government, if required, for withdrawal of declaration as institution deemed to be a University, in case of an institution deemed to be University;
- (j) recommend to the State Government to take necessary and appropriate action, in case of a University established or incorporated under a State Act;
- (k) Such other action as may be deemed necessary and appropriate against an institution for non-compliance.

Provided that no action shall be taken by the Commission under this regulation, unless the institution has been provided an opportunity of being heard to explain its position.

- 12. Nothing mentioned herein above in these regulations shall affect the continuance in office, during the currency of the term, of an incumbent Ombudsperson appointed under the provisions of the UGC (Redress of Grievances of Students) Regulations, 2019; where after, the appointment of Ombudsperson shall be made as per University Grants Commission (Redressal of Grievances of Students) Regulations, 2023.
